

## APPLICATION FORM

### AFFILIATE MEMBER

ULIS is a non-profit multi-stakeholder global network that supports lotteries in their mission to ensure integrity in sports. Its headquarters is based in Lausanne and it has operational hubs in Hong Kong, Copenhagen and Montreal. We offer a complete range of preventive (education and training) and supportive ecosystem of services (monitoring, detection, reporting, stakeholder & law enforcement collaboration) that are lottery savvy. Licensed State Lotteries, intergovernmental bodies, sports organizations, law enforcement authorities and regulators can all seamlessly collaborate and exchange information under one roof.

**The statutory requirements to become an Affiliate Member are reflected in Article 3.6 as follows:**

#### **3.6 Affiliate Members – Affiliates of a Regulating Member**

Affiliate membership is open to all sports betting operators licensed by a regulating ULIS member, or by a Gaming Regulatory body having the Status of ULIS Associate Member or by a gaming regulatory body which has provided ULIS with the official certified status of registered Integrity Platform.

The relationship between the regulator and ULIS is twofold: either ULIS is an official integrity body registered with the regulator or the regulator is a member of ULIS. The regulator can be a ULIS Regulating Member or a ULIS Associate Member – Public Authorities (non-lottery regulating betting authority).

As per article 3.5. Affiliate members should comply with the ULIS Code of Conduct. Affiliate Members have no voting rights but have the possibility, subject to approval by the ULIS Executive Committee to collaborate on specific operations, as well as education programs on prevention, investigation and related areas.

#### **To become an Affiliate Member:**

- The applicant must be licensed or authorized to conduct sports betting operations by a jurisdiction domiciled in a state recognized by the United Nations. ULIS Members operate only in jurisdictions in which they are licensed by the respective regulatory authority.
- The organization must be active in promoting sport at the local and/or national level and support grassroots sports
- The organization commits to financially support the activities of the association through its affiliate membership fees.

### The benefits for Affiliate Members include:

- Real-time e-mail alerts service available on sport events which are offered to bettors within the State
- Right to ask for a full detailed analysis of a certain sport competition
- Right to ask for an integrity grade and related recommendations when offering a new sport/competition
- Access to monitoring reports updates
- Access to education tools, including the right to request and propose targeted training
- Link between members and partners, national authorities, international bodies and assisting in the transmission and exchange of information

### Obligations of ULIS Affiliate Members:

ULIS Affiliate Members are committed to sharing the following information with the ULIS General Secretariat and Monitoring Hubs:

- Reporting any unusual odds movements observed in accordance with the ULIS framework
- Any views which may explain deviating/suspicious odds movements
- Geographic area and distribution channel of where the bets are taking place
- Follow up on alerts that were used to the extent possible
- Provide yearly updates on license

### Membership fee for Affiliate Members

The membership fee for Affiliate Members is CHF 10'000 annually.

### How to become an Affiliate Member:

Interested parties shall complete this application form and specify in writing their commitment to becoming part of ULIS.

This expression of interest must be made by the highest level of management of the applicant organisation. The letter must reflect the following:

- ✓ The grounds of motivation for becoming a member
- ✓ The overall comprehension and endorsement of the goals of the ULIS association

**Under no circumstances, is a ULIS affiliate member allowed to share ULIS data and/or resell ULIS services to any parties, which are not already ULIS Members. If a ULIS affiliate member does not comply with this obligation, the ULIS membership and services will be automatically discontinued.**
