ASSOCIATE MEMBER – SPORT ENTITIES

ULIS is a non-profit multi-stakeholder global network that supports lotteries in their mission to ensure integrity in sports. Its headquarters is based in Lausanne and it has operational hubs in Hong Kong, Copenhagen and Montreal. We offer a complete range of preventive (education and training) and supportive ecosystem of services (monitoring, detection, reporting, stakeholder & law enforcement collaboration) that are lottery savvy. Licensed State Lotteries, intergovernmental bodies, sports organizations, law enforcement authorities and regulators can all seamlessly collaborate and exchange information under one roof.

The statutory requirements to become an associate member are reflected in Articles 3.4 and 3.4.2 as follows:

Associate Membership

3.4 Associate membership is open to any organization interested in safeguarding the integrity of their operations and sports in general including gaming, intergovernmental organizations and relevant entities not mentioned in the subsections of this paragraph such as for example official national platforms under article 13 of the Council of Europe Convention on the Manipulation of Sports Competitions (CETS 215) without a public authority status.

Associated members have no voting rights but have the possibility, subject to approval by the ULIS Executive Committee, to collaborate on specific operations, as well as education programs on prevention, investigation and related areas.

3.4.2 Associate Members – Sport. Pursuant to paragraph 3.4, Associate membership is open under this paragraph to all sports organizations, including (non-exhaustive list) international and national sport federations, National Olympic Committees (NOCs), national and international governing sport authorities (such as national sports confederations and specialized sport units within ministries or government-commissioned or represented), sports associations (such as professional league associations).

The benefits for Associate Members include:

- Transmissions of relevant alerts at global level from the ULIS operational team
- Provision of education and prevention tools
- Regular transmissions of key information on sports integrity policy and regulatory developments
- Right to ask for full detailed analysis on a certain competition even though they don't have access to the monitoring platform
- Sponsorship opportunities in relation to Sports Integrity Events organised by ULIS



- Quotes and statements in ULIS communications and website as associate members
- Right to refer to ULIS in public statements and use of the ULIS logo for relevant purposes following prior communication to ULIS General Secretariat
- Access to monitoring reports updates
- Speaking opportunities at events

Membership fee for Associate Members - Sport

Membership fee for National Sports Organizations: CHF 5'000 annually. Membership fee for International Sports Organizations: CHF 7'500 annually.

How to become an Associate Member:

Interested parties shall complete this application form and specify in writing their commitment to becoming part of ULIS.

This expression of interest must be made by the highest level of management of the applicant organization. The letter must reflect the following:

- ✓ The grounds of motivation for becoming a member
- ✓ The overall comprehension and endorsement of the goals of the ULIS association

Under no circumstances, is a ULIS associate member allowed to share ULIS data and/or resell ULIS services to any parties, which are not already ULIS Members. If a ULIS associate member does not comply with this obligation, the ULIS membership and services will be automatically discontinued.
