REGULATING MEMBER

ULIS is a non-profit multi-stakeholder global network that supports lotteries in their mission to ensure integrity in sports. Its headquarters is based in Lausanne and it has operational hubs in Hong Kong, Copenhagen and Montreal. We offer a complete range of preventive (education and training) and supportive ecosystem of services (monitoring, detection, reporting, stakeholder & law enforcement collaboration) that are lottery savvy. Licensed State Lotteries, intergovernmental bodies, sports organizations, law enforcement authorities and regulators can all seamlessly collaborate and exchange information under one roof.

The statutory requirements to become a collective member are reflected in Article 3.5 as follows:

Lotteries, members of WLA or EL/NASPL/ALA/APLA/CIBELAE, acting as a sports betting regulator within their territory, are eligible to join ULIS as Regulating Members.

Regulating Members have one vote in the General Assembly regardless of the number of the licensees-affiliate members reporting to them.

Regulating members have the same possibility as Individual Members of applying for a single seat on the Executive Committee. If more than one Regulating Member is among the 4 highest votes, the Regulating member with the highest vote will be attributed the seat.

Other requirements:

- Be a lottery association acting as a sports betting regulator within its territory. The application must be empowered to provide licenses to conduct sports betting operations by a jurisdiction domiciled in a state recognized by the United Nations. ULIS Members operate only in jurisdictions in which they are licensed by the respective regulatory authority.
- Have the majority of the organization's net revenues dedicated to the public good.
- Be active in the promotion of sport at local and / or national level and supporting grassroots sports.

Obligations of Regulating Members:

Members are committed to share the following information with the ULIS General Secretariat and Integrity Monitoring Hubs:

- Reporting any unusual odds movements observed in accordance with the ULIS framework
- Any views which may explain deviating/suspicious odds movements

- Geographic area of where the bets are taking place
- Follow up of alerts that were used to the extent possible
- Promotion of ULIS activities in return for visibility of their activities
- Engagement and exchange with the General Secretariat to develop educational and strategic activities on the topic of sports integrity
- Provide yearly updates on licensees

The main benefits for Regulating Members include:

- Real-time e-mail alerts service available on sport events which are offered to bettors within the State.
- A 24/7 operational service availability if members need assistance or have any queries
- Right to ask for full detailed analysis on a certain sport competition
- Right to ask for an integrity grade and related recommendations when offering a new sport/competition
- A monthly risk assessment on upcoming dangerous fixtures (included in the monthly operational update
- Access to education tools, including the right to request and propose targeted training
- Access to legal/regulatory assistance
- Involvement in projects of which ULIS is a stakeholder
- Link between members and partners, national authorities, international bodies and assisting in transmission and exchange of information
- Invitation to the General Assembly with voting rights
- Possibility to sit on the ULIS Executive Committee
- Participation in studies, reports, research
- Regular transmissions of key information on sports integrity policy and regulatory developments
- Right to refer to ULIS in all company public statements and use of the ULIS logo for relevant purposes following prior communication to ULIS General Secretariat

Membership fee and special contribution:

The membership fee for Regulating members is CHF 15'000 per year.

How to become a Regulating Member:

Interested parties shall complete this application form and specify in writing their commitment to becoming part of ULIS.

This expression of interest must be made by the highest level of management of the applicant organization. The letter must reflect the following:

- ✓ The grounds of motivation for becoming a member
- ✓ The overall comprehension and endorsement of the goals of the ULIS association

Under no circumstances, is a ULIS collective member allowed to share ULIS data and/or resell ULIS services to any parties, which are not already ULIS Members. If a ULIS collective member does not comply with this obligation, the ULIS membership and services will be automatically discontinued.
